## TERMS AND CONDITIONS OF MEMBERSHIP APPLICATION

This application shall be subject to the terms and conditions contained herein as well as to the Association's constitution, charters and codes of conduct. By the signature of this application the Applicant is bound to all of the said terms and conditions.

- 1 In this agreement, unless the context indicates otherwise, the following expressions shall bear the following meanings:
  - 1.1 "SAVRALA" means the Southern African Vehicle Rental and Leasing Association
  - 1.2 "The Applicant" means the juristic entity/person described in this application form.
- 2 The Applicant agrees that this application for membership is subject to acceptance by the National Executive Committee of SAVRALA at its entire discretion and the committee shall in no way be obliged to accept such application nor justify its decision not to accept such application.
- 3 Membership of SAVRALA is annual and subject to submission of an annual application for renewal of membership and declaration of fleet.
- 4 The Applicant warrants that all its representatives from time to time shall be duly authorised to sign any document on behalf of the Applicant and in this regard, the Applicant may not challenge the authority of the aforesaid in any respect;
- 5 The Applicant's indebtedness at any time, or the fact that any amount is due and payable by the Applicant shall be deemed to be determined and proved by a certificate under the signature of any director or accountant of SAVRALA whose appointment as such need not be proved. Such certificate shall constitute sufficient proof to enable SAVRALA to discharge any onus, which may be cast upon it in any legal proceedings to obtain any judgment against the Applicant.
- 6 The Applicant shall pay all amounts under this agreement to SAVRALA based on SAVRALA's applicable schedule of fees and levies from time to time, on demand or within thirty days from date of the statement. If any payment is not made on due date, then SAVRALA may, without prejudice to any of its rights, charge interest at the legal rate on the amount overdue.
- 7 In the event that the Applicant breaches any terms and conditions of this Application or of SAVRALA's constitution or codes of conduct, SAVRALA shall

- 8 SAVRALA, its directors, employees, servants or agents are indemnified by the Applicant against any claim of any nature whatsoever and howsoever arising for any damages or loss which might be instituted against it arising from or connected with or pursuant to its membership of SAVRALA..
- 9 The Applicant chooses its domicile (domicilium citandi et executandi) for the purposes of execution of this agreement, whether in respect of Court processes, the serving of notices or the delivering of other documents or communications of whatsoever nature at the Applicant's address specified herein.
- 10 This document contains the entire agreement between the parties regarding the matters contained herein and SAVRALA shall not be bound by any undertakings, representations, warranties, promises or the like not recorded herein.
- 11 It is agreed that each clause of these terms and conditions is severable, the one from the other, and if any clause is found to be defective or unenforceable for any reason by any competent court, then the remaining clauses shall be and continue to be of full force and effect.
- 12 The Applicant further consents to the jurisdiction of the Magistrates Court, should SAVRALA, at its election, bring legal proceedings in a Magistrates Court, notwithstanding the fact that the amount involved exceeds the jurisdiction of the Magistrates Court. The Applicant hereby agrees, that SAVRALA in its sole and absolute discretion may institute any such action or proceedings in any division of the High Court that may have jurisdiction.
- 13 The Applicant expressly authorises SAVRALA to carry out a credit check on the Applicant and its directors / members / officers with any credit agency who may retain a record thereof and SAVRALA shall be entitled to record any default by the Applicant with any credit agency. Such records may be made available by the credit agency to third parties, in which case SAVRALA shall not be held liable/ responsible for any repercussions such disclosure may have on the Applicant.
